WHAT DO ORBIT LEASING AND CAR CITY DO WITH YOUR PERSONAL INFORMATION?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some, but not all, sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and Credit historyAccount balance and Payment history
- Income and Employment information

How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Orbit Leasing and Car City choose to share; and whether you can limit this sharing.

low do Orbit Leasing and Car City rotect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
low do Orbit Leasing and Car City ollect my personal information?	We collect your personal information, for example, when you Apply for credit or Open or maintain an account Show your driver's license or Make a payment Give us your employment information. We also collect your personal information from others, such as credit bureaus, affiliates, and other companies.
Vhy can't I limit all sharing?	 Federal law gives you the right to limit only sharing for affiliates' everyday business purposes—information about your creditworthiness affiliates from using your information to market to you sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing.
What happens when I limit sharing or an account I hold jointly with omeone else?	Your choices will apply to everyone on your account, unless you tell unotherwise.
Definitions	
ffiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. Orbit Leasing shares personal information with Car City. Car City shares personal information with Orbit Leasing.
lonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. Orbit Leasing and Car City do not share personal information with nonaffiliates.
oint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Orbit Leasing and Car City do not share personal information with nonaffiliated financial companies for joint marketing purposes.
